





Education

Łódź is one of the most important academic centers in Poland, with over 74,300 students enrolled in 20 Institutes of Higher Education—both public and private institutions. Nearly 5,000 of them are international students, and around 17,000 graduates receive their diplomas each year.

BSS Sector

The modern business services sector was the first to recognize Łódź's development potential during the city's economic transformation.

Thanks to a strong academic base, the city has become an attractive location for service-oriented projects.

The strongest segment of Łódź's BSS sector (BPO/SSC/GBS/CoE) is IT outsourcing. Other key areas include accounting and finance, banking, business analysis, HR and payroll, marketing, and customer service.

With over 35,000 professionals employed in this sector, Łódź ranks among the leading BSS hubs in Poland.

IT Sector

Łódź is rapidly expanding its IT sector, attracting both global corporations and innovative tech companies. The city is home to companies such as Accenture, Asseco, Comarch, Dell, Fujitsu, and TomTom, which have established IT service centres, software development hubs, and data analytics teams.






