COMMUNICATION INFRASTRUCTURE

ROAD COMMUNICATION

The Opolskie Province has one of the best-developed road networks in Poland. The A4 motorway, which is the most important communication route, is the main part of the Pan-European Transportation Corridor Berlin-Kiev and in the future Brussels-Rostov upon Don. The motorway is the element of the communication system, which concentrates the flow of the greatest number of commodities and people in the south of Poland. Simultaneously, it ensures efficient communication. The sites located in the neighbourhood of the motorway are very attractive particularly for prospective investors. They are concentrated within 6 centres by the motorway: 'Prądy', 'Dąbrówka', 'Gogolin', 'Olszowa', 'Nogowczyce'.



RAILWAY COMMUNICATION

The railway network in the Opolskie Province is twice as highly developed as those in other parts of Poland. A number of railway routes of great importance to domestic and international communication cross the Opolskie Province (routes: Dresden-Moscow, Malmö-Chałupki). The future plans include development and modernization of railway routes thanks to which quicker transport of a greater number of people and commodities will be ensured.



WATER TRANSPORT

The River Odra is a natural thoroughfare which flows parallel to the A4 motorway. Soon it should become an international inland water transport route. This water route, which is full of opportunities, crosses the Opolskie Province from the port in Koźle in the south of the region to Lipki on the border of the Lower Silesia Province. Kędzierzyński Canal and Gliwicki Canal play an essential role in water transport. The largest port is in Kędzierzyn-Koźle.



AIR TRANSPORT

The Nearest airports operating domestic and international flights: Wrocław (101 km) and Katowice (102 km). Two airports operating in the province: Kamień Śląski and Polska Nowa Wieś, the latter has a grass runway designed mostly for sports use. Kamień Śląski airport is a private one, a local airport for the Opolskie province is planned to be developed on the site.

Airport in Kamień Śląski

Possible development of Kamień Śląski airport:

- international connection service (cheap airlines),
- regular service to Germany,
- charter flights,
- cargo,
- General Aviation,
- Certified Centre for Aviation Training,
- airplanes from all over Europe.

The airport is an important element of the Opolskie Province communication system thanks to the infrastructure (concrete runway length is 2350 m and width is 60 m, the airport area – 285 ha, at a distance of 100 m from the airport there is a railway siding and a hotel where guests may stay while visiting Kamień Śląski and the Opolskie region); and its convenient location:

- 8 km from the A4 motorway,
- 105 km from Wrocław,
- 65 km from Katowice,
- 35 km from Opole,
- approximately 300 km from the German border,
- 45 km from the Czech border.



SOCIETY



The transformations of our region would not have been possible without the greatest wealth of this region – people who live here and are accustomed to hard and responsible work, open to new challenges. The Opolskie Province is the region with a wealth of traditions and harmonious cooperation of diverse cultures – Polish, Czech and German. Inhabitants of the region are open to international contacts and exchange of experience. Most of them work in the European Union countries, mainly in Germany, Austria, the Netherlands and Belgium. These contacts bring labour culture and standards of other countries to the local market. It influences skills improvement in the region and provides an excellent knowledge of EU employers. After their return, these people create new workplaces and strengthen SMEs by using their rich experience from the European labour market. The increasing level of personnel skills is one of the factors which stimulate the economic development of the Opolskie Province. The main academic centre of the region is Opole with 30 000 students. They constitute one-third of the Opole inhabitants.

Opole is an educational centre. There is Opole University – the greatest and most prestigious academic institution, and the Opole University of Technology – a technical higher school, from which graduates in construction, automation, robotics, electrical engineering and telecommunication, IT, mechanics and machines construction originate. There are courses in German and English.

Opole offers the following higher education opportunities: the Academy of Management and Administration - the largest non-public college in the region preparing students for business management, the State Medical College - educating healthcare personnel, the Faculty of Economics of Wrocław Banking College and branch of the Bogdan Jański College. Other education institutions in the region include the Vocational College in Nysa (educating technical personnel and conservation specialists) and the College of Fine Arts and Economics in Brzeg. In the Opolskie province there are 8 tertiary education institutions with a total of over 37 thousand students.





The Opolskie Province is the region with the richest agricultural tradition. Apart from industry, agriculture is the other pillar of the regional economy. Thanks to such geographical features as the high quality of the soil, lowland areas and mild climate, it is one of the best agricultural regions in Poland. ECONOMY OF THE REGION

Extensive sectoral structure:

- well-developed food processing and cement and lime industry facilities
- modern, advanced furniture and timber industry
- employment in private sector constitutes 79% of the total employment in industry
- number of businesses in the region totals about 93,000
- number two in Poland in terms of the rate of growth of the number of businesses

REGIONAL ECONOMIC TRENDS:

- increasing average employment rate in industry
- increasing average real gross remuneration
- decreasing unemployment rate
- increasing number of commissioned residential buildings
- increasing number of businesses
- increasing sold construction output
- increasing income from total business

From 1995 to 2005 the number of enterprises in the Opolskie Province increased two-fold and currently reaches 90,000. The majority are micro-enterprises (95.4%) with up to 9 employees. It shows development of entrepreneurship and activity of the inhabitants. Small and medium enterprises are one of the most important elements of the local economy. This sector reacts most quickly and effectively to the changing reality of markets, recognizes and satisfies the needs of customers and serves as the essential competitive challenge for big companies motivating them to change.

Natural resources, particularly the deposits of marls and limestone have a great influence on the economy of the region. Thanks to these mineral resources, the Strzelce-Góraždże region has developed, especially regarding cement-lime sector. The most significant companies are Góraždże Group (owned by HeidelbergCement consortium) and Lhoist Poland. The Opolskie Province is the place, which attracts foreign investors. The coefficient of a number of companies with foreign capital is 4.0 per 10,000 inhabitants, which gives the region a high ranking in Poland.

Within the Opolskie Province, a dozen of branches of industry have been developed and among them there are:

- Food processing
- Fuel-power
- Chemical
- Cement-lime
- Electromechanical
- Metallurgic and metal
- Furniture

The Opolskie province has excellent investment sites (especially along the A4 motorway) - such as the Economic Activity Zone at Olszowa or sites in Ujazd and Krapkowice municipalities. There are also subzones of special economic zones: Wałbrzych Special Economic Zone "Invest-Park" in Nysa, Skarbimierz, Opole, Namysłów, Praszka and Kluczbork and Starachowice Special Economic Zone in Tułowice.

One of the well-prepared investment sites in Poland belongs to the commune of Skarbimierz. It was distinguished during the competition 'Grunt na medal' and is included in the 'golden sixteen' of well-prepared grounds in Poland. In this area, Cadbury Schweppes plans to establish its factory - a €100 million investment project. This chewing gum factory is the greatest investment in the food industry in Poland.

The objective of the programme is to promote employment and professional development opportunities in the region, reducing mass employment migration, raising interest in education, further professional development in our region through promotion of the province's advantages and education possibilities and encouraging people working abroad to return to the province. The programme's partners include Opole businesses, entrepreneurs, labour offices, colleges, universities and schools in the region.



"OPOLSKA MARKA" (OPOLE BRAND)

The objective of the contest, held for five years now, is to support regional entrepreneurship, promote the best products and services and reward those, who, in these very competitive times, win foreign markets. Every year, the local businesses compete in four categories: Product, Service, Enterprise and Export - both in the SME and large enterprises sectors.




"GMINA ATRAKCYJNA DLA INWESTORA"

(MUNICIPALITY ATTRACTIVE TO INVESTORS)

The objective of the programme is to support local authorities in creating conditions to attract investments and motivate them to develop attractive investment offers.

Employees selected by municipalities have learnt at the workshops how to negotiate successfully and prepare promotional materials, as well as how to assist investors. Afterwards, both their municipalities and they themselves were audited. The managers were assessed in terms of their knowledge and competence, interpersonal skills and management style. The best local governments that during the verification process earned at least 80 points (out of 100), were granted three-star certificates attesting to their "very high level of qualification in domestic and foreign investors winning and assistance skills". The three-star municipalities included: Namysłów, Kietrz, Kolonowskie, Opole, Gogolin, Zawadzkie, Rudniki, Prószków, Zębowice and Kluczbork.

Betafence consortium (former Bekaert) was established in 1895 and has been transformed into the greatest Belgian company in the steel industry. In order to get closer to the customers from Central and Eastern Europe, the factory in Kotlarnia (commune of Bierawa) was built in 1993 and soon became the leading manufacturer and supplier of fencing systems and weldable mats in the Polish market.
