Location and road network

Piła lies on the Gwda river, on the border of western Pomeranian and Great Poland. Over a half of its area is occupied by woodlands and parks, situated among modern housing districts. Numerous lakes highlight the town's beauty. The town is surrounded by beautiful countryside and nature offering active forms of entertainment attracting both Polish and foreign visitors. Thanks to its geographical



location, the town plays a significant role in communications routes on the whole country scale. Motorways and railway lines which lead from the seaside to the south, to Poznań, Gorzów and further to Germany and from Szczecin and Świnoujście to Bydgoszcz, Toruń and Warsaw are crossing here. The nearest airport is situated in Bydgoszcz (90 km).

Economic structure

Most enterprises are connected with commerce, repair, real estate service, industrial processing and construction.

Investment opportunities

Well development technical, social and cultural infrastructure benefits the city's development in various branches of economy. The town has implemented modern traffic solutions. A ring road was constructed. The inner town ring road built thanks to the contribution from the European Union funds integrates the town space ensuring the proper quality of traffic. It also enables the economic activation of the areas near the former military airport. The beneficial conditions for investment are guaranteed by the Subzone of the Pomeranian Special Economic Zone being created in Piła.

Human resources, education

The well-developed secondary and higher education system has a big impact on the development of the local labour market.

Technological infrastructure

Investment area is fully equipped with technological infrastructure.

Foreign investors

There are over eight thousand companies including seventy-five ones with foreign capital in Piła such as Philips Lighting Poland, Philips Lighting Electronics, SCA Packaging Poland, Rijnart Centre Poland.

Tourist attractions

Natural assets of Piła and surroundings encourage people in active forms of tourism. The most picturesque places are: beautiful pine forests, lakes and rivers, numerous parks in the town, river's boulevards and the beautiful island at the Gwda bend. These are also historic churches: the neo-gothic St Stanisław Kostka's church, the neo-baroque Holy Family church on the west river Gwda bank and architecturally interesting the St Antoni Padewski's church.
