Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter the GDPR or the Regulation) will replace Directive 95/46/EC and is scheduled to apply in the EU Member States from 25 May 2018 onward.

Your personal data will be processed under Article 6.1.(a), (b) or (f) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data.

The controller's legal justification for the processing of your personal data is to establish or maintain business relationships with you and to carry out direct marketing of products or services offered by PAIH S.A., PCCNL, RVO, NPCC, Embassy of the Republic of Poland in the Hague.

The categories of your personal data to be processed are personal data that have been sourced directly from you (or have been provided in your name) or personal data gathered from public sources, specifically your first name and surname, email address, telephone number, mailing address.

The recipients of your personal data are employees and subcontractors as well as other service providers assisting the PAIH S.A, PCCNL, RVO, NPCC, Embassy of the Republic of Poland in the Hague in their business operations.

Your personal data will be retained and processed until you notify us of your intention to erase or restrict the processing of your personal data, or object to the processing of your personal data or else file a request to transfer your personal data.

Personal data retained for the purpose of sending commercial messages and for direct marketing will be retained and processed until you withdraw your consent to the processing of such data or until you request erasure or restricting the processing of your personal data, object to the processing of your personal data and request a transfer of your personal data.

You have a right to access, rectify, erase, restrict or object to the processing of your personal data, and the right to have your data transferred.

If you have expressed your consent to the processing of your personal data, you can withdraw your consent at any time, with no impact on the lawfulness of processing based on your consent before it was withdrawn.
