

Information on processing of personal data by the Polish Investment and Trade Agency

- 1. The Controller of your personal data shall be the Polish Investment and Trade Agency [Polska Agencja Inwestycji i Handlu S.A. (PAIH)], (address: Krucza 50, 00-025 Warsaw). The Data Subject may contact the Data Controller:

- 2. The Controller appointed the Data Protection Officer, whom you may contact in any and all matters pertaining to the processing of personal data and exercising the rights connected therewith. The Data Subject may contact the Data Protection Officer:

The purpose of and grounds for processing

- 3. Your data will be processed:
 - to recruit enterprises during the Business Forum at the Western Balkans Summit in Poznan, based on your consent (pursuant to Article 6(1)(a) of GDPR). Your personal data (name, business address, position in your enterprise, phone number, e-mail address) will be processes by the Controller electronically.
 - The personal data obtained with regard to the recruitment process shall not be transferred to a third country or an international organisation.
 - The personal data obtained with regard to the recruitment process shall be stored for the purposes of recruitment.
 - Natural persons, whose data was obtained, have the right to request access to their personal data (Article 15 of GDPR) and the right to rectify it (Article 16 of GDPR), erase or limit the processing pursuant to Articles 17 and 18 of GDPR, the right to transfer (Article 20 of GDPR) and the right to object.
 - A person, whose personal data is processed with regard to the implementation of the recruitment process, may lodge a complaint with the Lead Authority if they are of the opinion that the processing of their personal data infringes upon the personal data protection rules.
 - The provision of personal data is voluntary, but also necessary for the purposes of recruitment. Failure to provide the data may render the execution of the rights and obligations hereunder impossible.
- 4. Recipients of the data.

Your personal data may be transferred to: entities from the PFR Group (PFR, PFR Venture, PFR TFI S.A., KUKE S.A., PARP, ARP S.A., BGK), entities supervising the operation of PAIH S.A. and public administration bodies (Ministry of Foreign Affairs, Ministry of Entrepreneurship and Technology, State Protection Service) or the co-organisers of the Western Balkans Summit in Poznan (Poznan International Fair).

5. Consent and the right to withdraw the consent.

You shall have the right to withdraw your consent for the processing of your personal data at any time, but the withdrawal of consent shall not affect the lawfulness of the processing based on your consent before its withdrawal.
