

# AI 50: AI x IOT x SMART CITY

## ORIGIN

Smart city has become a crucial part for city managers in the process of policy-making and solving common problems within the city: transportation, healthcare, education, housing, environment, and urban sustainability, which are brought about due to high population density. Since 2014, Smart City Summit & Expo (SCSE) has invited professionals from all around the world, including both city and industry leaders, to share their experiences in smart city development, and to showcase innovative smart city solutions.

The booming applications of face recognition, autonomous vehicles, smart commerce and industrial automation have demonstrated the growth of Artificial Intelligence (AI). The combination of AI and Internet of Things (IoT) is now widely applied to the innovation of smart cities, bringing more intelligent and high-quality municipal services to the citizens with new opportunities for the urban economy.

## PURPOSE

To highlight the application of Artificial Intelligence (AI) technology in smart cities, the 2020 Smart City Summit & Expo (SCSE) will launch the second edition of **"AI 50: AI x IoT x Smart City"** campaign on a bigger scale, sending invitations to the world's best AI startup companies to showcase their solutions. 1. Accelerating the application and implementation of AI technology in smart cities
2. Introducing AI technology to existing industries to encourage industrial transformation

2. Field Application Effectiveness (40%)
3. Potential of Team's Research and Development (20%)
4. Operating Performance (10%)

**Bonus 1.** Recommended by accelerators or venture capital firms (20%)

**Bonus 2.** Solutions or applications NOT using public cloud (30%)

## SELECTION PROCESS

1. The AI 50 Committee will select qualified applicants based on documentary evaluation. If necessary, the Organizer may request applicants to submit supporting materials for further review.
2. The result of selection will be sent to applicants via email. If selected, please inform the Organizer of your attendance status before **February 10<sup>th</sup>, 2020**. For those who fail to notify the Organizer of the attendance before the abovementioned date, the claim to the rewards and the rights to participate in the campaign shall be forfeited.
