### Fintech. Cyber. Biometrics. Your trusted Trio From Poland

The financial technology market in Poland continues to grow, there is a steadily increasing number of operating entities. As for the most popular categories of operation of Polish fintechs, they include payments, financial management and software delivery. Distinctively, in Poland, the boom in the sector we've seen in recent years has come primarily from cooperation with mature financial institutions, rather than through direct competition. The Fintech's Digital Assets market in Poland is projected to grow by 3.38% (2024-2028) resulting in a market volume of €11.82bn in 2028.

### Fintech

### HISTORY

The Polish financial ecosystem is relatively young, especially when compared to the Western, well-established banking traditions. This has presented as an opportunity to the Polish emerging FinTech sector and the young banks- digitalizing their operations in the 90s, unburdened by the dead ends of technology implemented by older banks abroad and ready to implement trailblazing digital solutions. The Polish bank's willingness to innovate and the lack of customer pressure to support the already outdated solutions allowed the banks to jump ahead and skip the mistakes. These were, and still are, major drivers for the rapid growth of the FinTech sector in Poland.

### SIZE AND GROWTH

There are several factors driving this growth, including:

- overall macroeconomic growth,
- increasing demand for technology-enabled financial services,
- the large number of highly-skilled experts and technical university graduates, changing customer behavior (accelerated by the COVID -19 pandemic),
- and an increasing pressure to meet ESG standard

The introduction of the EU's PSD2 Payment Services Directive, which requires, among other things, stronger security of customer funds in banking, is having a positive impact on the development of technology and companies implementing AI and biometrics in FinTech.

### SEGMENTATION

The FinTech landscape in Poland can be divided into two major areas

The first one consists of non-bank FinTech players, which are both financial service providers and technology suppliers. This group can be subdivided into 10 areas of specialisation: payments, deferred payments, bureaux de change, loans and credits, online factoring, crowdfunding, insurtech, corporate treasury management, personal finance management, blockchain and cryptocurrencies.

The second one comprises technology providers to the financial sector (FinTech software providers, cybersecurity and identity verification and artificial intelligence) and providers of financial comparison engines.

The largest number of Polish fintechs provide payment services and they account for more than 22% of all Polish fintechs. The second place is occupied by software providers (12.5%). The further segments' market share is distributed more evenly.

55% of Polish fintechs focus on business customers, while 31% offer their services individual customers. The B2B share is steadily increasing, indicating a progressive focus on business customers in various configurations. At the same time, 12% of fintechs offer their services to consumers through other institutions.

Up to 40% of Polish fintechs are present on foreign markets.

### **BLIK - CASE STUDY**

Probably the most well-known fintech in Poland is Blik. This unique mobile payment system was launched in 2015, originally created by a joint venture of six incumbent Polish banks, that became a universal mobile payment solution. It had 1 million users already in the first six months. Currently, there are almost 13 million of them. Over the eight years of its operation, its users have completed almost 2.8 billion transactions worth PLN 371.4 billion (in 2022 alone, it was 1.2 billion operations worth PLN 163.9 billion). In the future, Blik has a chance to become a pan-European payment system. The first countries to which expansion is planned are Slovakia and Romania.

Blik is based on a 6-digit code generated in the user's banking app. It can be used in e-commerce transactions, to withdraw money from an ATM, at a POS terminal to process payment in a brick-and-mortar store, or for sending peer-to-peer (P2P) transfers. The convenience of this payment method was the main reason for its success and quick adoption.

### POLISH LEADERS IN CYBERSECURITY

According to Polish Cyberspace Defense Forces, during February 2024, Poland has become the most attacked country in the world with over 1000 cyber-attacks on organizations occurring per week.

The number of cyber-attacks increased dramatically in 2022, after the Russian invasion of Ukraine in February 2022. On the other hand, however, Poland ranked first in the National Cyber Security Index, which measures a country's level of cyber security, its preparedness to prevent cyber threats and its readiness to manage cyber incidents, crime and large-scale crises, according to the Cyber Defence Forces.

In the area of regulation, in 2024 the cybersecurity industry expects the completion of the amendment to the National Cyber Security System Act (NIS2), which will, among other upcoming European regulations like DORA and the CRA directive, increase the security of critical infrastructure.

Most Polish companies offer solutions in the segment of network security, malware protection, identity verification and confirmation and encryption, a very well-developed segment of specialised cybersecurity services- compliance, audits, pentesting, incident handling, etc.

In Poland, in particular, solutions related to the automation of offensive security, industrial security (OT) and observability and monitoring of networks and infrastructure are growing dynamically.

In the period of 2020-2023, the leaders in cybersecurity were banks, the army and police, and technology companies in Poland. The market is expected to grow to PLN 2.52 billion by the end of 2024, with an annual growth rate of eight percent.

### **Biometrics**

### **BIOMETRICS IN BANKING** POLAND THE FIRST TO IMPLEMENT BIOMETRIC SOLUTIONS **IN EUROPE**

Biometrics falls into the basic two categories- behavioral and physiological. Both categories and their respective forms are being successfully implemented into banking.

#### **Behavioral biometrics :**

### **Physiological biometrics :**

In Europe, Poland was the first to implement biometric solutions. Since 2009. Podkarpacki Bank Spółdzielczy (Subcarpathian Cooperative Bank), tested the solution in one of its branches, and in 2010 began installing biometric ATMs, using fingerprint biometrics.

Biometric login using a fingerprint is today the standard for logging in to mobile banking and is used by most banks in Poland.

Examples of applications of implementing biometrics in FinTech in Poland include:

- biometric credit cards- offered by Bank Pocztowy (Polish Post Bank), there are currently no Polish providers of this solution,
- voice biometrics- this method is not gaining much popularity • in Poland, but it is offered, among others, by Santander Bank,
- . handwritten signature biometrics- there are Polish firms providing such solutions and banks implementing them,
- . facial biometrics- Polish banks offer "selfie" account opening or video verification (e.g. Pekao, BZ WBK, Santander),
- behavioral biometrics- implemented by most banks in Poland. . It is possible that there will be a statutory obligation to use behavioral biometrics Poland, the Payment System Council is involved in devising a proposal of such regulations. There are Polish providers of such solutions.

## Al in Fintech

While many biometric solutions use AI technologies, AI itself also has broader applications in FinTech, which include:

- streamlining transactions,
- risk assessment and fraud detection,
- personalized marketing,
- customer service and chatbots,
- analyzing data and market trends.

Many possible specific applications of AI have not yet been discovered or developed, and thus the market is growing exponentially, rife with opportunity for startups and smaller businesses to develop their own, custom-tailored solutions.

A large number of Polish companies carry out orders for clients from all over the world. More than half of the companies cooperate with universities and academics.
