### §1 Basic definition

Whenever the following terms are mentioned in these Regulations, they shall be understood as:

1. **Agency – Polish Investment and Trade Agency** with its registered office in Warsaw at ul. Krucza 50, 00-025 Warsaw.
2. **Applicant** – an entrepreneur applying for the opportunity to participate in a Polish-Finnish event promoting Polish brands and products in Finland and Poland as an attractive location for foreign investments. **Event** – Polish-Finnish event supporting business relations, promoting Polish brands and products in Finland, and promoting Poland as an attractive location for foreign investments, which will take place on June 10, 2026 in Helsinki (Finland).
3. **Participant** – entrepreneur using dedicated conference space at a Polish-Finnish event promoting Polish brands and products in Finland and Poland as an attractive location for foreign investments.

**Co-organizer** – Polish Investment and Trade Agency S.A. with its registered office in Warsaw at ul. Krucza 50, 00-025 Warsaw. **Service or Provision** – the Agency providing free use of conference space at a Polish-Finnish event promoting Polish brands and products in Finland and Poland as an attractive location for foreign investments.

### §2 General Provisions

1. The provider and operator of the conference space made available is Polish Investment and Trade Agency S.A., with its registered office in Warsaw at ul. Krucza 50, 00-025 Warsaw, hereinafter referred to as the “Agency” or “PAIH S.A.” The Regulations for participation in the Event, hereinafter referred to as the “Regulations,” set forth the principles governing participation in the Event and the use of related services.

### §3 Application procedure for participation in the Event.

#### 1. Application process:

- The Applicant shall complete the electronic application form made available on the Agency’s website by 11:59 p.m. on 8 June 2026.
- The Applicant agrees to the terms of use of the Service set out in the Declaration and in these Terms and Conditions, and undertakes to comply with any instructions and guidelines issued by the Agency.



2. The Applicant applying for the use of the Service must meet the criteria specified in §4 of the Terms and Conditions. The completion and submission of the application form by the Applicant shall be deemed equivalent to a declaration that, as of the date of submission, there are no circumstances preventing the Applicant from participating in the Event. This includes, inter alia, the ability to finance the necessary logistical costs related to participation in the Event.
3. The completion and submission of the application form by the Applicant shall not be equivalent to qualification for participation in the Event, nor to receiving a positive decision regarding participation.

#### **§4 Method of Decision-Making Regarding the Applicant's Participation in the Event.**

1. Due to the limited number of places, admission to participation in the Event shall be determined by the order of applications received.
2. The decision on the qualification or non-qualification of a Participant shall be communicated to each Applicant by email by the Head of the Foreign Trade Office in Helsinki. No appeal procedure shall apply to this decision.
3. In the event that a qualified Applicant withdraws from participation in the Event, the Agency shall contact the next Applicants on the reserve list.
4. The Agency reserves the right to cancel the recruitment process in the event of a Force Majeure event or if the Agency decides to refrain from organizing/cancelling the Event. In such case, the Agency shall bear no liability towards the qualified Applicant/Participant, in particular no liability for damages for costs incurred in connection with the organization of participation in the Event or for loss of profits.
5. "Force Majeure" shall mean an external event beyond the control of a Party, independent of the Party, which could not have been foreseen and which cannot be avoided or whose effects cannot be prevented, provided that such event affects the implementation of the Event, including in particular natural disasters, a state of epidemic or epidemic threat, war, or terrorist threat.

#### **§5 Rules for the Use of the Space**

1. The Event Participant is obliged to:
  - a) read and comply with these Regulations,
  - b) promptly inform the Agency of any changes concerning their participation in the Event,
  - c) observe safety and order regulations.
2. The Participant shall use the conference space allocated by the Agency for the Polish–Finnish event promoting Polish brands and products in Finland, as well as Poland as an attractive location for foreign investment.
3. The use of the Service is free of charge for the Participant.



### §6 Responsibility

1. The Agency shall not be liable for any damage to or loss of movable property brought into the Event by the Participant. The Agency does not provide security services, including supervision of the Participant's property brought to the Event.
2. The Agency shall not bear any liability towards the Participant in the event of cancellation of the Event or shortening of its duration due to reasons beyond its control, in particular as a result of Force Majeure.
3. The Participant is obliged to immediately inform the Agency of any damage occurring within the designated conference area.
4. In the event of a breach of the Regulations, the Participant may be charged with the costs of repairing damaged property, in an amount documented by the Agency. The Participant shall bear full responsibility for any damage caused through their fault in connection with the shared use of the conference space, towards the Agency as well as other users of the conference space during the Event. The Participant's responsibility for any culpable damage to any element of the conference space during the Event shall not be limited and shall entail the obligation to fully compensate the damage in an amount not lower than that incurred by the Agency in relation to another Participant or other entities using the conference space.

### §8 Personal data protection

1. The Agency processes participants' personal data in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Dz.Urz.U.E.L 119, p. 1), hereinafter referred to as "Regulation 2016/679." The information clause is available on the Agency's website at the following address: [Information clause concerning the processing of personal data of participants of event – Polish Investment and Trade Agency](#). The qualified entity undertakes to inform all persons referred to in Article 14 of Regulation 2016/679 of the content of the Agency's information clause.
2. The processing of Participants' personal data in the form of their image, in particular through its recording, use, and dissemination in the form of photographs or video recordings made during the Event by the Polish Investment and Trade Agency S.A., with its registered office in Warsaw, ul. Krucza 50 (00-025 Warsaw), is carried out on the basis of Article 6(1)(f) of Regulation (EU) 2016/679, in conjunction with voluntary consent (such consent is deemed to be granted through participation in the Event) pursuant to Article 81 of the Act of 4 February 1994 on Copyright and Related Rights (consolidated text: Journal of Laws of 2022, item 2509).
3. The consent referred to above may be withdrawn at any time. Withdrawal of consent shall not affect the lawfulness of processing carried out on the basis of consent before its withdrawal.



### §9 Final provisions

1. In justified cases, the Agency reserves the right to change the dates of the Services agreed with the Participant and specified in these Terms and Conditions. The Participant shall be informed of such change by telephone or via the email address provided in the application form. Changes concerning the location or promotional concept shall not constitute grounds for any claims against PAIH S.A.
2. All organisational matters not regulated in these Terms and Conditions shall be decided by the Agency.
3. Matters not regulated in these Terms and Conditions shall be governed by generally applicable provisions of Polish law.
4. These Terms and Conditions are governed by Polish law and shall be interpreted in accordance with it.
5. Any disputes arising under these Terms and Conditions shall, in the first instance, be resolved amicably.
6. Any disputes arising under these Terms and Conditions which cannot be resolved amicably shall be subject to the jurisdiction of the Polish common court competent for the registered office of the Agency.
7. During the Event, photographs and recordings (hereinafter referred to as the "Materials") may be taken. Materials depicting Participants' logos and trademarks may be used free of charge by the Agency for the purpose of informing about the Event and promoting future events of a similar nature to the Forum on the Agency's website, the Agency's profiles on social media platforms (e.g. Facebook, Twitter, LinkedIn, YouTube), as well as in various media (documents, publications, industry portals, etc.). The Participant consents to the dissemination of such Materials through their publication by the Agency on its website and social media profiles both during and after the Forum for promotional or informational purposes. Individual attending the Event consent to the free of charge dissemination of their image recorded in photographic materials as well as materials recorded using devices capturing image and sound, disseminated via the Agency's website and the Agency's profiles on social media platforms (e.g. Facebook, Twitter, LinkedIn, YouTube), for informational and promotional purposes related to the Agency's activities.
