Częstochowa is one of smaller BSS centers in Poland, however it provides a competitive counterbalance to the offer of the nearby GZM Metropolis. The city functions as an economic, cultural and administrative center of the northern part of Silesia. What is important for the Business Services Sector, there are 5 universities that cooperate extensively with local employers. As a result, every year, nearly 4,000 graduates enter the labor market and are prepared to work in the business. They include IT specialists, engineers, accounting and finance specialists, among others.

The Al motorway connects the city with the Silesian Agglomeration. The great location ensures a quick, 30-minute access to the Katowice Airport. Most of the cities of the GZM Metropolis are within a 1-hour drive, which additionally increases the availability of qualified labor. The Częstochowa city authorities provide support to investors through a dedicated Investor Center and the Technological Park. Companies interested in obtaining tax exemptions can count on the support of the Katowice Special Economic Zone.

Apart from the abovementioned advantages, Częstochowa's offer is

characterized by competitive real estate prices, low living costs and access to qualified labor force, which led to such investors as ZF TRW, SFC Solutions and Sii opening their business service centers there. The scope of services provided includes, among others, IT, research and development, finance and accounting. ZF TRW's financial and accounting center in Częstochowa provides services for all its factories located in Europe. The company has also located an Engineering Center and an IT Center there, both cooperating with the global network.

A favorable business environment, access to human resources and free space for new investments are undoubtedly the main advantages of the city. The offer of Częstochowa and other smaller centers is an important supplement to the offer of larger cities from the so-called TIER 1 or TIER2 category, proving the competitiveness and attractiveness of Poland for this sector and allowing for its sustainable development.

For years, Częstochowa has been strengthening its position on the Polish map of regional cities that are an attractive location for companies from the business services sector. It is here that shared service centers or IT companies increase their presence every year and provide valuable services to their national and international clients. Częstochowa is also the most important urban center located in the north of the Silesian Voivodeship, providing strong support for Katowice and Metropolis GZM. A good base of office properties and access to human resources are conducive to

the launch of medium-sized operating centers with BPO / SSC and IT profiles.


Nearest airport: Katowice-Pyrzowice (56 km). Regular destinations





According to the observations of The Adecco Group experts and data from the Central Statistical Office in Poland, the average salary in the Silesian Voivodeship oscillates around PLN 4500 gross per month. The most attractive salaries are offered in Katowice. Slightly lower in Częstochowa.

However, specialisation is a key factor influencing the level of remuneration. IT and research and development experts can count on the most attractive salaries. At the bottom of the list there are specialisations related to sales, customer service and physical work.
